The copyright and any and all other intellectual property rights, title and interest in the Work (including without limitation all performer’s property rights and all other such rights under section 77 and section 80 of the Copyright Designs and Patents Act 1988 as I now have or hereafter acquire in the Contribution) shall vest in and are hereby assigned to RAH (and this assignment shall operate to the extent necessary as a present assignment of future copyright).

1. RAH shall have the unfettered right to deal with all or any part of the Work in such way that it thinks fit, including, but not limited to, using, exploiting, amending, distributing, storing and sub-licensing the Work for any purpose in connection with the products and/or services of RAH and/or any affiliated entities of RAH (including, but not limited to, for the publicity purposes of RAH and/or any affiliated entities of RAH) by all means, in all media and formats (for the avoidance of doubt, including, but not limited to, written or oral reproduction of a testimonial, where appropriate) and in any territory in perpetuity.
2. In respect of the Work, I hereby irrevocably waive in favour of RAH, its assignees and its licensees the benefit of all moral rights and performers’ rights arising under the Copyright, Designs and Patents Act 1988 or similar rights arising under the laws of any jurisdiction.
3. RAH may use my name, likeness, biography and image (including, but not limited to, in the medium of photograph or film) in conjunction with the use of the Work by any and all means in any and all media and formats (including without limitation any social media page(s) and within RAH’s own internal and external platforms including, but not limited to, RAH’s external and internal websites, print, adverts, Facebook, YouTube, Twitter and Instagram) in any territory in perpetuity.
4. RAH shall be entitled, at its reasonable discretion, to edit, copy, alter, add to, take from, adapt and/or translate the Work.
5. To the fullest extent permitted by law, RAH shall not be liable, in negligence or otherwise, for any loss, damage or injury to the Artist arising from or in connection with the Work and/or the Project.
6. The Work shall not contain anything which is an infringement of copyright or which is calculated to bring RAH and/or any affiliated entities of RAH into disrepute or which is defamatory.
7. I shall keep confidential all the details and the content of the Project. I agree that I will not publish or authorise the publication of or broadcast or authorise the broadcast of or disclose in any other manner any material or information relating to the Project.
8. The Courts of England shall have sole jurisdiction in relation to this Artist Release Form which shall be interpreted according to the laws of England.
